Plaintiff Jeanne Gergen brings this action pursuant to 42 U.S.C. § 405(g) seeking review of the denial of her application for disability benefits. This matter is before the court on plaintiff's motion for judgment on the pleadings (Doc. 6) and defendant's motion to dismiss or for judgment on the pleadings (Doc. 8). For the following reasons, defendant's motion to dismiss or for judgment on the pleadings is granted, plaintiff's motion for judgment on the pleadings is denied, and this action is dismissed for lack of subject matter jurisdiction. I. Factual and Procedural Background On September 1, 1995, plaintiff filed an application for supplemental security income ("SSI") benefits. Tr. at 44. Plaintiff's application was denied initially and on reconsideration. Tr. at 22, 26. Plaintiff then requested a hearing before an Administrative Law Judge ("ALJ"). Tr. at 2d92ce491b
